Because of its commitment to educating local students who will stay in the area, it has attracted gifts from individuals, corporations, and foundations with ties to the community. The Foundation's annual appeals reach a broad constituency of approximately 3,800 donors. The Foundation is re-designing and re-evaluating its fundraising campaigns to engage and attract new donors. New campaigns have been launched to support students through Emergency Student Scholarships, appeals based on most significant needs, and targeted appeals to Galveston College alumni.

(iii) Sources of Support: The Foundation historically has received support from a broad representative number of foundations and individuals rather than almost all of its support from the members of a single family or small group of individuals. During the fiscal year ending 8/31/2023, the Foundation received contributions from 85 unique donors.
